### OVERVIEW

Mount Ridley Mines Ltd (ASX: MRD) (or “the Company”) is pleased to provide the following update of activities for the Quarter ended 30 June 2020.

Although there was no material information reported on the Company, the Company has maintained the statutory requirements of its Mount Ridley licenses.

In accordance with Listing Rule 5.3.1, the Company advises it incurred expenditure of \$130,000 in relation to the exploration and evaluation of its mining projects during the quarter. The majority of this expenditure is related to the creation of a detailed database on the Mount Ridley Project including detailed core logging.

In accordance with Listing Rule 5.3.2, The Company advises there was no substantive mining and production activities during the quarter.

The Company also continues to evaluate future opportunities when presented. Should the Company identify a suitable asset, the Company will keep the market informed.

### CORPORATE

#### Longland Resources Limited

At the beginning of the quarter, the Company advised that due to the prevailing market conditions at the time, the Board decided not to proceed with the acquisition of Longland Resources Limited announced on 23 January 2020.

#### Payment to Related Parties
